# IDC World Championship IGP Hosting Conditions:



Director for training / work IDC

The IDC usually takes place in the first weekend of May.

A postponement of the IDC WM requires consultation with the President or the IDC Board.

The award is made at the annual IDC Congress.

Each member club of the IDC, which meets the requirements of holding the event can apply to host the event in writing.

The application must be submitted to the committee meeting before the Congress of IDC each year. Member countries who are celebrating an anniversary in the relevant year will be given first preference.

5 dogs may start per country plus one reserve dog, which, however, must be registered at the latest by the closing date for entries.

## Prerequisites for the award:

The sequence of the event will be clarified by the director of working and in cooperation with the IDC committee, taking into account the valid examination regulations.

The participating dog handlers must provide proof of third party insurance and proof of rabies vaccination with their entry. The valid vaccination certificate must be with the trial management no later than the start of the trial.

Phase B / C must be held at a sports ground.

It must be ensured that the catering is guaranteed and that there are sufficient parking spaces available for dog handlers and officials, in the immediate vicinity of the ground.

Access to the ground and parking area for spectators must be available.

Possible camping facilities with electricity and water, as well as reasonable sanitation facilities must be adequately available.

# The following shall be done on the day:

Confirmation and allocation of the tracking ground.

The tracking ground should be of sufficient size, so that if required there is sufficient ground for alternate tracks.

#### Tracking ground and its allocation:

May not be announced prior to the event and may not be accessed by dogs or people.

The transport of the participants to the tracking ground must be carefully organised. Two traffic guides must ensure that the convoy does not separate in traffic, so all participants arrive at the tracking ground at the same time.

Judges transport and catering for the officials and tracking helpers must be available.

## While the track is aging the tracking ground must be watched for trespassers.

## Provision of all equipment required by the trail regulations:

- Micro-chip reader
- Tracking stakes/flags, numbered articles
   2 x 6 mm Pistol and ammunition
- o Dumbbells IGP
- Hurdle 1 metre.
- Scaling wall 1.80 metre.
- o 6 hides for the defence/protection phase
- Marking spray/chalk for the ground
- o Helpers for all work required for the implementation of the event
- Stewards/ First aid services
- Veterinary care not the whole day
- Support of trial leader and secretary
- Care of the officiating judge, helper and track layer
- Arrangement of 4 people trained for the group, dressed as uniformly as possible
- The availability of a so-called test dog for phase B
- Judges reports and writing implements

Participants must wear starting numbers that match the number in the program header in all phases of the trial.

These Numbers will be given at the draw, and must be returned after the award ceremony.

Dog handlers who are not ready at the scheduled time may be excluded from the trial.

Eligible participants are only reported by your team leaders or the IDC member country.

Startberechtigt sind nur Teilnehmer die von Ihren Mannschaftsführern bzw. des IDC Mitgliedslandes gemeldet wurden.

The entry fee / registration fee is payable upon receipt of the entry for the participants of the team. The entry is bound to the recognition of the IGP and all existing animal welfare laws. No manipulation may be carried out on a participating dog. Otherwise - even retrospectively - the results / titles will be stripped.

The introduction of nations and parade of participants / handlers must be made with dogs and team captains.

At the stadium when competing in phase B / C the sports uniform of the team must be worn.

Training vests, or other clothing which could be used as motivation or assistance are not allowed.

Complaints about the event can only be made by the team captain.

The parade to the award ceremony takes place with dogs, and also the start numbers.

There must be at least 2 test dogs which are to be presented on Friday at the beginning of the defence work test in the phase C. The dogs are selected by the organiser.

Execution Conditions IDC WM IGP, Page 2 of 3

The host will prepare a certificate signed by the president for each participant / handler that has, with his dog, passed the trial. The name of the dog and handler and score and value judgment should it be evident.

Furthermore, each participant should receive a small gift as a reminder. The costs are borne by the organiser. The organiser is however exempt from awarding special prizes.

The organiser must obtain appropriate insurance to sufficiently protect the protection helpers against personal and property damage.

A possible loss of earnings should be taken into account when the insurance is obtained.

In addition, the organiser will, at its own cost have third party insurance for the trial day. Control is taken over by overall management.

All technical preparation, including advertising costs (posters) are assumed by the organiser.

In addition, the organiser will inform all team leaders/participants in writing, the agreed upon schedule, meeting points (directions) and starting times etc.

Roads and paths to the test grounds are properly and clearly sign posted by the organiser.

Furthermore, the host must provide sufficient parking.

Corresponding folders must be available to ensure the smooth running of the event.

The working judges of the various countries will be, in agreement with the IDC President / IDC working director, will be invited by the test leader.

The travel costs of judges are charged to the delegated member country and will be covered in full. All other expenses (accommodation, meals etc.) are paid by the organiser of this event.

The cost of protection helpers and tracklayers are also paid by the organiser.

The host of the IDC IGP WM will receive a subsidy of 3500 Euro.

With the application, the host of the IDC WM / IGP agrees to all of these regulations/conditions.

Changes and additions are valid only with the written consent of the IDC committee.

#### Verbal agreements are not valid.

Promoter = IDC Organiser = Host Country

The above regulations were restated due to a decision by the IDC committee on 29/10/2022 and is in effect from 01.02.2023.

Earlier regulations are thus invalid.
